Course Description

The class provides an overview of the study of the US Constitution, the state government of Arizona, and political philosophies, nationally and worldwide. Also, this course focuses on the criminal justice system and its ramifications: criminality, crime prevention, victim rights, and the court systems, federal and state. Students must participate in the Chandler Justice Court "Teen Court" program. Participation in the Arizona High School Mock Trial competition is optional.

- -RESTROOM: Students are to, one, sign the restroom sign-out sheet with date and time in/out, and two, get restroom pass signed by teacher prior to leaving. Please be mindful of timing ... restroom breaks will be allowed at our BREAK TIME and AFTER presentations, assignment completion, and/or lecture. Phones are not allowed to be taken to the restroom.

- -PROJECTS can be turned in late up to one week only being able to earn a max of 70% of the assignment's total points.
- -TESTS can be made up within one week from its administration date due for an EXCUSED absence only.
- Also, e-mail assignments are not accepted. Please have a back-up plan...save your work and plan for printer access BEFORE an assignment is due. Assignments are still due on their assigned dates and times. Homework is not to be printed in between classes.

Assessments and Assignments

Students will complete assessments during each unit of study to assess their understanding. Students will complete the CUSD Common Final at the end of the first and second semesters. The Common Final will count for 20% of the student's final semester grade in grades 9-12 and 10% in grades 7-8 (some exceptions may apply at the Junior High level). Common finals will be in ELA, Math, Science, Social Science, and World Language.

Final exams will be given during the CUSD Jr High/High School Early Dismissal days in December and May, as identified on the <u>District Calendar</u>.

If students are requested to participate in a survey, the survey questions will be provided to parents/guardians seven days before student contact.
