4.01 Out of State Student Travel Preplanning

An out of state field trip pre-planning form for BHS was provided. Following Governing Board preapproval, the Superintendent (designee) will monitor trip arrangements before providing final approval.

Requested approval of the items generously donated to Chandler schools totaling \$2,104.92.

#### 4.03 Monetary Gifts

Requested approval of the monetary gifts generously donated to Chandler Schools totaling \$480,571.76.

#### 4.04 2016-17 IGA with City of Chandler

Recommended Board approval of the 2016-17 Second Amendment for sole source procurement for the City of Chandler Police Department in the total amount of \$872,242 which covers the seven SROs at: Basha High, Chandler High, Hamilton High, Andersen Jr. High, Bogle Jr. High, Santan Jr. High and Willis Jr. High with the understanding that the grant will be presented to the Board annually for approval. The total actual salary and benefits amount for all seven officers is \$906,015. It is estimated that the "Safe Schools Program Grant" will fund \$838,468 leaving a shortfall of \$67,547. Per agreement, CUSD and the City of Chandler will split this with each paying \$33,773.50.

#### 4.05 Proposition 301 Pay for Performance Plan

A.R.S. 15-977 (Classroom Site Fund) requires that a school district governing board must adopt a performance based compensation system in order to allocate funding from the classroom site fund. The 2016-17 Proposition 301 Pay for Performance Plan has minor changes from last year's plan and has been approved by the District's SuperProp Committee.

These changes consist of:

- Anticipated payment of \$2750 per staff member to be paid in 2017-2018.
- The CUSD Pay for Performance Plan, which has three components will continue to be based on:
  - 1) (\$917) Each eligible staff member completing 12 hours of District designated professional development outside of contract time.
  - 2) (\$916) The Site reaching their 301 Goals based on AzMerit scores.
  - 3) (\$917) Teachers Performance Classification.
    - Highly effective and effective teachers will receive 100%; developing teachers (in their first two years) receive 75%; developing teachers (with 3+ years of experience) receive 50%; and ineffective teachers receive 0%.

### 4.05 Proposition 301 Pay for Performance Plan (cont'd)

This performance based compensation system was presented in a Public Hearing on December 7, 2016; requested final approval.

### 4.06 White Copy Paper for Warehouse Stock

Recommend approval of the lowest responsive and responsible bidder, Liberty Paper, to provide 8,400 cases of white copy paper at \$21.87 per case totaling \$183,708; with tax, the grand total will be \$198,038.22 per Bid #105-17-17.

#### 4.07 Modified Salary Schedule

Due to the recent passage of Proposition 206, a \$10.00 minimum wage requirement will be in effect beginning January 1, 2017. In response, the District is moving forward to increase the hourly rate for individuals who are earning less than \$10.00 per hour. The minimum wage is scheduled to increase steadily over the next three years. At this time, there is no need to modify the support staff hourly salary schedule. Each employee is still within the appropriate range. However, approval for a modification to the miscellaneous compensation schedule to change the student worker rate from \$8.05 per hour to "minimum wage" was recommended. Any changes to the support staff salary schedule will be forwarded to the Super Q team during the normal budgeting process for consideration and recommendations for the 2017-2018 school year.

# 6.01 Pre-School Hands on Science Adoption

CUSD continues to enhance early childhood offerings with academic emphasis and age appropriate expectations. These science modules encourage scientific learning through hands-on play-based activities. The expenditure for the 33 pre-school sites will not exceed \$72,604. This cost will be covered by grant funds and district capital budget allocated towards curriculum.

### 6.02 Great Books and Shared Inquiry

Great Books K-12 and Great Books K-5 include product and professional development to support critical thinking, text complexity, close reading, collaboration and writing. Great Books materials support achieving college and career readiness through balancing literary and informational text, building core knowledge in several disciplines by requiring explicit evidence-based response and vocabulary expansions. The purchase of this curriculum is encompassed under the common schools umbrella of Arizona Revised Statutes and Arizona Administrative code.

### 6.03 Policy Modifications for Distribution of Promotional Materials

Chandler Unified School District will begin using a third-party flyer management system to electronically publish promotional materials. This change triggers modifications to existing Policies KD-Public Information and Communication, KHC-Distribution of Promotional Materials and Exhibit KHC-E - Request to Distribute Materials. These changes were presented as Information and will be presented for approval at the January 25, 2017 Regular Board Meeting; Exhibits do not require board approval.
