2.01 Override Election Options

Joel Wirth, Chief Financial Officer, presented information on a November 2017 or 2018 Override Election explaining the timeline for consideration. The budget committee will consider the options and make a recommendation to the board.

Lana Berry, Assistant Superintendent for Business Services, presented the 2017-18 Budget Projection reviewing the additional funds because of growth, which were more than anticipated. She also shared details about the second sale of the 2015 bond which will include the payoff of our existing lease for Auxier Elementary and Casteel High School. The School Facilities Board (SFB) approved three projects for FY 2017-18 for a total of \$21,578,925 in addition to approving additional square footage for secondary in the 2018-19 school year. The next steps are for the Joint Legislative Budget Committee (JLBC) to fund the SFB recommendations. Lana reviewed the Food Service financials, the Governor's proposed budget for school year 2017-18 which would be split between all school districts in Arizona and the Legislative Agenda.

8.02 New Policy IHAMC-Instruction and Training in Cardiopulmonary Resuscitation

Arizona School Boards Association (ASBA) Policy Advisory 553 has recommended a new Policy IHAMC-Instruction and Training in Cardiopulmonary Resuscitation. Senate Bill 1137 amended A.R.S. 15-718.01 and 43-1089.01, related to school curricula. The substance of this legislation directs school districts and charter schools to offer instruction and training in cardiopulmonary resuscitation (CPR) as a mandatory, not a discretionary, duty. CPR instruction and training is required to be provided no later than July 1, 2019. This Policy IHAMC-Instruction and Training in Cardiopulmonary Resuscitation is presented as Information; approval will be requested at the February 22, 2017 board meeting.
