6.04 <u>2016-17 Carl Perkins Intergovernmental Agreement</u>

The 2016-17 East Valley Institute of Technology (EVIT) Intergovernmental Agreement (IGA) for Carl Perkins Career and Technical Education (CTE) programs was submitted for approval.

6.05 Change Order for Technology Expenditures

On May 18, 2016 the Board approved the "Annual Technology Expenditures" for the upcoming 2016-2017 school year in the amount of \$3,000,000. An increase of \$1,000,000 was requested for a total of \$4,000,000, as a result of the high demand of technology purchases. This increase is partially due to computer-based testing and assessment during the 2016-2017 school year.

6.06 <u>Increase Dollar Amount for Transportation Purchase Orders</u>

On June 22, 2016 the Governing Board approved the sole source and extended contracts. The Transportation Department requested approval to increase the dollar amounts for the following vendors, all of which are on Mohave or State contracts and follow all procurement requirements.

- Auto Safety House originally requested \$215,000; the total required is \$365,000 (an increase of \$145,000)
- Canyon State Bus Sales originally requested \$145,000; the total required is \$525,000 (an increase of \$380,000)
- RWC International originally requested \$180,000; the total required is \$625,000 (an increase of \$445,000)
- Mel's (Napa) Auto Parts originally requested \$20,000; the total required is \$100,000 (an increase of \$80,000)

6.07 New Policy IHAMC-Instruction and Training in Cardiopulmonary Resuscitation

Arizona School Boards Association (ASBA) Policy Advisory 553 recommended a new Policy IHAMC-Instruction and Training in Cardiopulmonary Resuscitation. Senate Bill 1137 amended A.R.S. 15-718.01 and 43-1089.01, related to school curricula. The substance of this legislation directs school districts and charter schools to offer instruction and training in cardiopulmonary resuscitation (CPR) as a mandatory, not a discretionary, duty. CPR instruction and training is required to be provided no later than July 1, 2019.
