# 5. Comments

5.01 <u>Citizen Comments</u>

Christina Burke and Christina Nguyen, parents in the District, addressed their desire to help establish support groups for suicide prevention programs at schools in Chandler District, emphasizing the need to further educate staff and students.

## 6. Consent Agenda

6.01 Out of State Student Travel Preplanning

Out of state field trip pre-planning forms for BHS, CCHS, HHS, and PHS were provided. Following Governing Board pre-approval, the Superintendent (designee) will monitor trip arrangements before providing final approval.

- 6.02 <u>Monetary Gifts</u> Requested approval of the monetary gifts generously donated to Chandler Schools totaling \$80,162.74.
- 6.03 <u>Donations</u> Requested approval of the items generously donated to Chandler schools totaling \$18,181.18.
- 6.04 <u>Resolution for School Facilities Board Funding Casteel High School Phase III</u> District administration requested that the Governing Board approve the resolution resolving that funding in the amount of \$10,455,000 will be set aside and available to pay for cost beyond regular Arizona School Facilities Board (ASFB) funding for the construction of the Casteel High School Phase III, located at 24901 S. Power Road, Queen Creek, 85142. This amount will be less any unused ASFB funds that will become available for use by the School District as approved by SFB Staff at the conclusion of this project.
- 6.05 <u>Resolution for School Facilities Board Funding Hamilton High School Addition</u> District administration requested that the Governing Board approve the resolution resolving that funding in the amount of \$6,900,000 will be set aside and available to pay for cost beyond regular Arizona School Facilities Board (ASFB) funding for the construction of the addition to Hamilton High School, located at 3700 S. Arizona Avenue, Chandler, 85248. This amount will be less any unused ASFB funds that will become available for use by the School District as approved by SFB Staff at the conclusion of this project.
- 6.06 <u>Contract Renewal with Chandler Education Foundation</u> Requested approval to renew the contract between Chandler Unified School District (C.U.S.D.) and the Chandler Education Foundation (C.E.F.) for the 2017-2018 school year including four (one-year) renewable options. Approval of this contract allows the C.E.F. to function as C.U.S.D.'s non-profit partner to assist, provide services and support our students, staff and community.

6.07 Pre-Kindergarten English Language Arts

Big Day for Pre-Kindergarten, an English Language Arts curriculum, was presented to the Governing Board as an Information item on May 24, 2017. After the curriculum was placed on public display for a 60day review period and public comment, if given, was collected and reviewed, approval was requested for the Big Day for Pre-Kindergarten curriculum for implementation in the 2017/2018 school year. Total cost of \$104,965 is budgeted through the District textbook allocation.

#### 6.08 Speech Therapy Services

Requested approval to contract Speech Therapy Services per RFP-156-15-20 from the recommended awarded vendors for a not-to-exceed amount of \$1,204,800 for fiscal year 2017-18 on an as-needed basis in order to provide appropriate, high-quality services to students in the absence of district employees.

#### 6.09 Psychologist Services

Requested approval to contract Psychologist Services per RFP 156-15-20 to provide appropriate, highquality services to students in the absence of district employees on an as-needed basis from the recommended awarded vendors for a not-to-exceed amount of \$74,500 for fiscal year 2017-18.

### 6.10 Nursing Services

Requested approval to contract for Nursing Services as per Deer Valley Unified SD SAVE RFP S36-15-19 and Dysart USD RFP G117-17-22 on an as-needed basis from the recommended awarded vendors to provide appropriate, high-quality services to medically fragile students for a not-to-exceed amount of \$611,300 for fiscal year 2017-18.

#### 6.11 <u>Hearing Impaired Interpreter Services</u>

Requested approval to contract Hearing Impaired Interpreter Services to provide appropriate, high-quality services to students in the absence of district employees per the Deer Valley Unified SD SAVE RFP S36-15-19 Special Education Services on an as-needed basis from the recommended awarded vendor for a not-to-exceed amount of \$17,500 for fiscal year 2017-18.

### 6.12 Vision and Orientation & Mobility Therapy Services

Requested approval to contract Vision and Orientation & Mobility Therapy Services to provide appropriate, high-quality services to students in the absence of district employees from the recommended awarded vendor on an as-needed basis for a not-to-exceed amount of \$31,000 for fiscal year 2017-18 per the Gilbert Public Schools RFP 77-14-18.

### 6.13 Special Education Day Schools

Recommended approval for a not-to exceed amount of \$5,300,000 for special education day schools on an as-needed basis as determined by the Director of Student Services for services received between July 1, 2017 and June 30, 2018. Reports will be provided to the Board for review on a quarterly basis.

### 6.14 Personnel Policy Revisions

Along with an increase to minimum wage, Prop 206, the Fair Wages and Healthy Families Act, changed the law related to accrual and use of paid sick leave. Prop 206 gives the Industrial Commission the authority to enforce and implement the Act. The proposed policy changes are derived from Prop 206 language, current administrative rules and Arizona statutes, and an official document issued by the Industrial Commission. Because of the major changes in Policy GCCA, the current policy will be eliminated and replaced with a new version. Policy GCCA-Professional/Support Staff Sick Leave, GCCB-Professional/Support Staff General/Emergency/Religious Leave (General Leave), GCCG-Professional/Support Staff Voluntary Transfer of Accrued Sick Leave (Medical Leave Assistance Program), GCCH-Professional/Support Staff Bereavement Leave and GCG-Part-time and Substitute Professional Staff Employment were presented as Information at the July 12, 2017 Board Meeting. Recommended approval.

Arizona School Boards Association (ASBA) has recommended the following modifications to existing policies:

- DJE Bidding/Purchasing Procedures
   Policy DJE has been modified in response to district audit questions pertaining to compliance in
   contracting with small and minority businesses, women's business enterprises, and labor surplus
   area firms.
- EBAA Reporting of Hazards/Warning Systems House Bill 2190 initiated changes to a number of education or education related statutes. Corresponding changes have been made to policy documents based on the statutory language that has been added or deleted.
- IJNDBA Website Accessibility
   This is a new policy addressing website accessibility covered in W3C/WAI's Web Content
   Accessibility Guidelines 2.0, Level AA conformance, or updated equivalents of these guidelines.

These Policies will be presented for approval at the August 23, 2017 board meeting.

#### 8.06 Personnel Policy, Exhibit and Regulation Revisions

Arizona School Boards Association (ASBA) and Chandler Unified School District have recommended changes to the following Policies, Regulations and Exhibits:

- GCC-R Professional/Support Staff Leaves and Absences Editing language to reflect the current systems in place.
- GCF-EB Professional Staff Hiring (Procedures and Practices for Employment Authorization and Employment Eligibility Verification)
- GDF-EC Support Staff Hiring (Procedures and Practices for Employment Authorization and Employment Eligibility Verification)
   The above two exhibits have been edited to include changes to I-9 requirements made by the U.S. Citizenship and Immigration Services (USCIS) which has published a revised version of Form I-9, Employment Eligibility Verification, effective January 22, 2017.
- GCGC-R Job Sharing in Professional Staff Positions Minor change in regulation to match policy.
- GCO Evaluation System for Certificated Teachers Due to a recent revision in the teacher evaluation protocol, Governing Board Policy GCO has been revised. The revisions are primarily due to a change of terms. The instructional practice components have been changed from Domain 1 (Classroom Strategies), Domain 2 (Planning and Preparing), and Doman 3 (Reflecting on Teaching) to Standards-Based Instruction, Conditions of Learning and Standards-Based Planning. The policy has been updated to reflect the new language.

Approval for Policy GCO will be requested at the August 23, 2017 board meeting. Regulations and Exhibits do not require board approval.
