Janelle Wood, Black Mothers Forum, expressed their desire to partner with the District to address concerns. The Black Mothers Forum are requesting a study session where they can discuss and address policies and curriculum with board members.

Dr. Matthew Whitaker, from the East Valley MLK Committee and Diamond Strategies, LLC, offered the services of himself and his team as a friend and colleague to work with the District. His company helps others understand diversity, equity, inclusion, cultural competency, community relations and making the mix work for black students in particular.

Joann Wuthrich, active parent in the District for 22 years, encouraged the Board and administration not to be swayed by the cameras and social media. - 7.03 Intergovernmental Agreement with Arizona Career and Technical Education (CTE) Curriculum Consortium for the 2017-18 School Year

The Arizona CTE Curriculum Consortium Intergovernmental Agreement for CTE teacher resources, instructional materials and professional development automatically renews annually. The Board approved the initial Intergovernmental Agreement (IGA) in June 2013. The IGA was renewed and signed by both CUSD and PIMA JTED in November 2016. Through participation, CUSD will receive quality professional development for CTE teaching staff to enhance teaching and learning as well as access to a wiki developed by the consortium. The cost to CUSD associated with program membership, maintenance, on-going development and necessary revisions is projected not to exceed \$18,000. Joint Technical Education District (JTED) funding will be utilized to fund CUSD's participation.

Requested approval to the following policies as recommended by Arizona School Boards Association (ASBA):

- *IJNDB* Use of Technology Resources in Instruction The recent passage of SB 1314 added section 15-1046 to the Arizona Revised Statutes, relating to the Student Accountability Information System. This requires notifying a parent of policies regarding the use of technology and the Internet while at school and the parent's ability to prohibit the student from the use of technology and the Internet while at school. Exhibit and Regulation for IJNBD have also been modified for clarity.
- *JFB Open Enrollment* A.R.S. 15-184(I), Charter schools; admissions requirements, and A.R.S. 15-816.02, Desegregation provisions, have been deleted from the statutes in SB 1254. Corresponding deletions have been made in the Charter Handbook and in the Policy Manual.

The District issued a Request for Qualifications to general contractors for the construction on 11,244 square foot wing at Auxier Elementary. A Guaranteed Maximum Price (GMP) of \$1,960,000, or \$174.32 per square foot, was negotiated, which is a fair and reasonable price. If approved construction will begin in October 2017 and conclude around the end of May 2018. 8.03 Secondary Assessment and Blended Learning Solutions

The Arizona Department of Education has recently moved AIMS Science from paper-based administration to computer-based administration. As a result, 4th grade, 8th grade and high school students will be expected to take AIMS Science on a computer. Currently, our device to student ratio at the Jr High and Elementary levels is sufficient to accommodate. To successfully administer these exams at the high school level, Chandler Unified School District needs to purchase 1,080 HP Streams to be stored in 36 charging carts at a cost not to exceed \$457,855.58.

In accordance with the A.R.S. 15-722(D), Chandler Unified School District is bringing to the attention of the Governing Board the use of the following textbook as supplementary for instruction in AP Physics at Casteel High School.

The supplementary textbook has been reviewed by the Chandler Unified School District Curriculum Department and Casteel High School. This textbook is appropriate for providing instruction in the standards of the course.

In accordance with the A.R.S. 15-722 (D), Chandler Unified School District is bringing to the attention of the Governing Board the use for the following textbook as supplementary for instruction in the AP Seminar course offered at Hamilton High School and Basha High School.

• Uncharted Territory: A High School Reader, Edited by Jim Burke

This supplementary textbook has been reviewed by the Chandler Unified School District Curriculum Department and by both Hamilton and Basha High School. This reader is appropriate for providing instruction in the standards of the course.

- 9.04 Revisions to Policies related to Transportation Arizona School Boards Association (ASBA) has recommended changes to the following policies and regulation:
 - Policy EEAEA-Bus Driver Requirements, Training, and Responsibilities • House Bill 2247 modified the requirements for school bus drivers who must submit an Identity Verified Finderprint Card as described in A.R.S. 15-106 that the Department of Public Safety (DPS) shall use to process the fingerprint clearance card.

DPS shall suspend a school bus driver certificate if the fingerprint clearance card is invalid, suspended, canceled or revoked. On or before December 31, 2018, a person certified as a school bus driver must obtain a valid fingerprint clearance card and submit an Identity Verified Fingerprint Clearance Card as prescribed by A.R.S. 28-3228 to maintain certification. A person who is certified as a school bus driver who holds a valid fingerprint clearance card may use the current valid fingerprint clearance card to satisfy requirements until such fingerprint clearance card expires, whereupon the school bus driver must obtain and maintain a valid Identity Verified Fingerprint Clearance Card for the duration of any school bus driver certification period.

- Policy EEAG-Student Transportation in Private Vehicles •
- Regulation EEAG-R Student Transportation in Private Vehicles •
- Policy EEB-Business and Personnel Transportation Services These documents have been modified to include language requiring that school district employees or Governing Board members, prior to any use of private vehicles to either embark on business/personnel transportation or to transport students, acknowledge that the employee or Governing Board Member's automobile insurance is the primary coverage and that proof of insurance must be given to the district prior to such transportation being initiated.

Chandler School District recommends adopting the policies as proposed by ASBA. Approval will be requested for the policies at the October 18, 2017 regular board meeting; Regulations do not require board approval.

9.05 Revisions to Policies related to Food Service

The United States Department of Agriculture has provided guidance related to unpaid meal charges through Department Memos SP 46-2016, 47-2016, AND SP 23-2017, "Unpaid Meal Charges: Clarification on Collection of Delinquent Meal Payments." Guidance provided in these memos has been incorporated into Policy EFDA and JL. Please note that ASBA Policy Services has suggested specific conditions related to Meal Charges, but are not mandated by USDA. However, USDA does mandate that conditions are established by districts. As long as districts comply with USDA guidance, these conditions can be locally determined.

Chandler School District recommends adopting the policies as proposed by ASBA. Approval will be requested for the policies at the October 18, 2017 regular board meeting.
