Tax Anticipation Notes are used to cover operating deficits created by uneven property tax collections and state aid receipts. This is an annual request. RES - TANS 2018 – Chandler USD – Resolution is presented for consideration and authorizes the District to sell up to \$50,000,000 in Tax Anticipation Notes. The District will sell the notes to the Maricopa County Treasurer.
