1.01 Chandler Education Foundation Update

5.04 <u>Intergovernmental Agreement with Arizona Career and Technical Education (CTE) Curriculum Consortium for the 2019-20 School Year</u>

The Arizona CTE Curriculum Consortium Intergovernmental Agreement for CTE teacher resources, instructional materials and professional development automatically renews annually. Through our participation, CUSD will receive quality professional development for our CTE teaching staff to enhance teaching and learning as well as access to a wiki developed by the consortium. The wiki contains over 1,000 common designed lessons to over 19 CTE programs.

Consideration and Possible Adoption of a Resolution Approving Forms of and Authorizing the Execution and Delivery of a Ground Lease, a Lease-Purchase Agreement and other Necessary Documents for Financing the Costs of Purchasing a School Site and Constructing School Buildings

Requesting approval of the resolution relating to a ground lease and a lease-purchase agreement not to exceed \$36,000,000. The lease purchase proceeds will be used for two main purposes, funding a portion of the new secondary land site and to fund construction for Elementary 31. If the 2019 Bond is approved in November by Chandler Unified School District voters, it is expected that the district will pay the lease off by July 1, 2021.
