## 6.04 Architect Selection for High School #7

A RFQ (request for qualifications) was issued for the selection of an architectural design team for high school #7. A committee of 12 evaluated each response and unanimously ranked H.D.A. Architects number one. Negotiations have taken place between H.D.A. and the District reaching an agreement on a fixed cost of \$3,850,000. This represents 5.5% of a projected \$70,000,000 construction cost. This fee of 5.5% is extremely competitive and very fair and reasonable. H.D.A. has been the architect of record on Basha High, Perry High and Casteel High Schools as well as numerous elementary schools. Recommended approval of H.D.A. Architects for \$3,850,000 for architectural and engineering services for high school #7.

#### 6.05 Modular Relocation to CTA Liberty

CTA Liberty's growth has required the relocation of one modular building from CTA Freedom to CTA Liberty. McCarthy Building Company has been selected via a JOC (job order contract) to perform the designated scope of work, which complies with all school procurement rules. McCarthy has proposed a cost of \$396,392 based on three previous projects. This cost is fair and reasonable. Recommended approval of McCarthy Building Company for the modular relocation to CTA Liberty for \$396,392.
