6.02 Vista Higher Learning 60-day review

The Vista Higher Learning Spanish resources will be used by 6th grade Dual Language Immersion Teachers at CTA Liberty to support Spanish instruction. Additionally, the Vista Higher Learning resources will be used at Bogle Junior High and ACP Oakland to support students transitioning into junior high who are fluent in speaking Spanish (heritage speaker). In accordance with ARS 15-721, the curriculum will be placed on display for the 60-day public review period for comment at the Melinda Romero Instructional Resource Center starting April 23, 2020.

Board members discussed the proposed 2021 Political Agenda. This year, they have the opportunity to submit the priorities established for the 2020 legislature. 7.01 <u>Superintendent Comments</u>

Dr. Casteel stated that while our buildings are closed to the public during Arizona's Stay Home, Stay Healthy, Stay Connected, a great deal of work is going on behind the scenes. Our teachers and students continue to adapt to this new way of delivering instructional materials. Professional Development for staff is continuing, particularly the elementary staff in use of Google Classroom.

We have prioritized communication and routinely roll out information to our parents and community. Everything we have communicated is archived and published on our website.

Our Human Resource Department led by Mrs. Cooper is working to hire staff for next year. Food Services Department is providing approximately 75,000 meals a week at 10 locations to try to ensure that children 18 and under are not going hungry.

Former Governor, Jane D Hull, and her husband, Dr. Terry Hull, passed within hours of each other on the same day. Hull Elementary is named after Jane Hull to honor her work for public education. She was instrumental in many things during her tenure as governor, including School Facilities Board funding for building schools.

In light of school closures, we are in planning meetings and collaborating with other East Valley Districts related to end of year celebrations for graduates, retirees and summer school options. In lieu of a retirement celebration, letters and clocks will be mailed to all retirees. More information will be available in the next two weeks.

David Evans echoed condolences to Jeanette Polvani and her family. Jane Hull was a great governor who defended education. David mentioned he missed seeing the High School Student Body Presidents at board meetings to hear about their end of year activities and future plans.

Dr. Casteel responded that Barb Mozdzen had written a letter to each of them to be mailed with their gifts, since they could no longer attend board meetings.

Lara Bruner thanked the District and community for pulling together; the teachers for being creative; and the IT people who have stepped up to help with the virtual world.

Barb Mozdzen agreed that it had been a team effort from many people i.e. teachers, staff, parents, students, administration, community members. A special thanks to the nutrition department for providing nutritional meals for children who depend on us.
