Minutes of a Regular Board Meeting of the Governing Board

Office of the Board Maricopa County, Arizona November 18, 2020 7:00 p.m.

## 1. Study Sessions - 4:30 pm

### 1.01 COVID-19 / Virtual Instruction Discussion

Dr. Casteel opened by acknowledging all the emails received and assured everyone that the board and administration read all of them. Tonight the administration will present our plan and rationale for moving forward. The District is watching the State, County, and community levels and working closely with the Maricopa County of Public Health. For many, fatigue has set in for wearing masks and distancing. Dr. Casteel encouraged everyone to recommit to those mitigation strategies. The district is taking this very seriously and watching the data closely.

Dr. Craig Gilbert, Assistant Superintendent of Secondary Education, shared county data and specific to zip code date within the Chandler School District, explaining the current District situation. We are transparent for our district. Larry Rother, Senior Executive Director for PK-12 Educational Services, explained the mitigation strategies currently in place and the updated CDC mask guidelines, encouraging parents to keep students at home if they are exhibiting signs of illness. He shared the updated dashboard and current data from CUSD. Dr. Gilbert shared the strategies for maintaining in-person learning. The data shows that the rates in the community do not mirror the rates in our schools. Social/emotional supports are more readily available in-person than online. He explained that we can control where students are when they are in school, but not when they are online or out of school. Research also shows that online school is more difficult for students in grades K-3. Frank Narducci, Assistant Superintendent of Elementary Education, shared the plan to return to a virtual learning environment when a school reached a certain percentage level. Mr. Narducci explained the timeline and process for a temporary closure if a school hits the threshold of student/staff active COVID-19 cases.

Board members asked about the availability of substitutes and resources available to help students; strategies to relieve the stress of staff and families; procedures when someone tests positive; support for those feeling depression and anxiety (students and staff); ensuring a seamless experience from the classroom to virtual and maintaining the rigor level, and stated that the district must be prepared and remain flexible to flow for the benefit of students and staff. Barb Mozdzen mentioned that nation-wide studies show that the spreading of the virus is not happening at the same rate in schools as it is in communities. Lara Bruner and Lindsay Love do not feel this plan is adequate and would like to see the District in a hybrid mode.

#### 1.02 Integrated Units

Dr. Jessica Edgar, Elementary Curriculum Director; Katie Moe, Assistant Director Chandler Online Academy/Elementary Connect; and Jena Phillips, Elementary Science Instructional Coach, presented on Integrated Units. Dr. Edgar shared the details, and the design including the five E components - Elaborate, Engage, Explain, Explore and Evaluate. Katie Moe explained the details of the Roadmap that teachers use for the units. Jena Phillips explained and demonstrated an actual lesson. Being that the models are created by CUSD staff and recommendations are suggested by the users (teachers), adjustments are easily made. They reported that the buy-in from teachers has been fantastic.
