# 1. Study Sessions - 5:30 pm

1.01 Intel/Dell/CUSD Community Partnership

Colleen Flannery, Executive Director of K-12 Technology Services, and Shaun Creighton, Assistant Director, presented information regarding the new partnership between Intel, Dell, and Chandler Unified School District, beginning with the early design stages and concluded with the desired outcomes. Larry Rother, Intel, and Michael Franklin, CHS principal, participated. Leah Rogers and Tom Osmun, Dell, joined electronically to share details about the partnership. Dell and Intel donated \$1.6M to purchase devices for this 1:1 project. Michael Franklin shared the survey results from teachers, students and families and the excitement amongst teachers for this project.

#### 1.02 International Baccalaureate Primary Years Programme

Leo Schlueter, Director of Elementary Education, introduced Andersen Elementary Principal, Kristen Kinghorn, and a team of teachers to present information regarding the International Baccalaureate Primary Years Programme beginning at Andersen Elementary. The team talked about the learner of the 21st Century, enrollment decline, core values, which lead them to exploring the International Baccalaureate Programme. The elementary program will create a pathway to the Middle Years Programme and the Diploma Programme at CHS. Authorization is an intensive process that lasts at least two years and includes site visits.

#### 10.02 Chandler Unified School District partnership with Intel and Dell Technology

In March 2021, Chandler Unified School District was approached to participate in a three-way partnership with Intel, Dell and CUSD. The partnership resulted in a proof of concept that would bring best practices and an integrated solution to education technology. The proof of concept would address the digital divide, IT resourcing, finances, and student needs. As the part of the proof of concept, the district would like to

10.02 <u>Chandler Unified School District partnership with Intel and Dell Technology</u> (cont'd) implement a 1:1 program at Chandler High School and CUSD will need to purchase 4,000 devices from Dell Technologies. The cost is \$737.77 per device for a total of \$2,951,085.11. This proof of concept includes a \$1.6 million donation in hardware and services from Intel and Dell Technologies. The purchase will be made using the State of Arizona contract number ADSP016-098163 which complies with all school procurement rules.

10.06 Purchase of Activity Buses

After reviewing the District's student transportation fleet, administration is recommending the purchase of five (5) additional activity buses for a total of \$419,665.61 to help meet the growing needs of routes, sports, clubs and school activities. With the challenges Chandler, and the rest of the nation, are facing attracting CDL drivers, activity buses give us the flexibility to support our district's needs with non-CDL drivers. These five 14-passenger activity buses are less costly to maintain and operate as well. All vehicles will be purchased through the Mohave Educational Services Cooperative contract 18F-CSBS-0904 - Canyon State Bus Sales which complies with all applicable procurement rules and were selected based on price, inventory, and life cycle costs.

#### 11.05 Superintendent Comments

Frank Narducci thanked the host families of our foreign exchange students and specifically board member Mr. Olive and his family for providing a wonderful experience for these students. Tarwater students had a unique experience earlier today. They were able to communicate with United States Astronaut Shane Kimbrough as he was aboard the International Space Station. This once-in-a-lifetime experience involved alot of coordination to live stream with the space station at exactly 11:31 am. Students had 10 minutes to ask questions. Principal Hale and a partnership including Amateur Radio on the ISS and NXP Ham Radio Club coordinated this event. A special thank you to NXP Ham Radio Club volunteers and our very own Michael Holland and the Chandler Education TV crew. The event will be archived on Chandler Unified YouTube Channel. Additionally, articles written by Tarwater students will appear in local publications. Tarwater was the only school in Arizona selected to participate this year. Tarwater students and staff will be invited to a future board meeting to discuss the preparation and the actual experience.

The Student Services Center recently earned All-Star Status by the Arizona Department of Education Exceptional Student Services Division. All-Star Status is given to districts that meet or exceed the statewide participation and engagement rates. CUSD's class of 2020 students with disabilities exceeded the statewide participation rate with a 91% participation rate and 82.5% engagement rate, which also exceeds the state rate meaning that our students were meeting their transition plans beyond high school. In large part, this is due to our transition specialists at each high school and their ability to connect with families and students to check in on them a year later.

Additionally, we have been actively participating with the Center for the Future of Arizona in a program called Participatory Budgeting. The program was recognized yesterday with a 2021 ASU President's Award and Renee Sweeden attended the event. Chandler Unified is the second district to partner with the Center for the Future of Arizona Schools. The Participatory Budget project enables students to decide together how to spend public money. These participatory budgeting processes deepen democracy, build stronger communities, and make public budgets more equitable and effective.

With the holidays right around the corner, our Chandler CARE Center is busy preparing for its Thanksgiving Family Assistance program scheduled for Saturday, November 20th. We are accepting donations of whole frozen turkeys, 2-pound bags of rice and dry pinto beans, canned vegetables, canned fruit, soup, cake mix and frosting, instant mashed potatoes, side dishes and paper goods as they prepare to give families the makings for a complete Thanksgiving dinner. Mr. Narducci expressed his appreciation for all the school efforts in this collection.

Mr. Narducci also thanked the Chandler Community for their generous giving to the Chandler Education Foundation's annual Cash for Classrooms campaign. Time has been spent the past few weeks with Jen Hewitt, Executive Director of the Foundation, awarding grants to increase engagement in learning. He also thanked the groups for the two presentations during the Study Session: 1) Technology partnership with Intel and Dell for CHS and 2) the IB Primary Years Program. There are many exciting things happening for CUSD students.

#### 11.06 Board Member Recognition / Comments

Jason Olive commented on the Foreign Exchange Student reception earlier this evening, stating it would be nice to send CUSD students abroad as exchange students. The experience puts things into perspective. The State Department has promoted the program since the 1950's.

Barb Mozdzen acknowledged these experiences create lasting friendships.

*Joel Wirth* addressed the Override by stating there are misunderstandings and clarified this is not an increase in taxes, it is a continuation. Many property taxes in Chandler are less than last year. *Barb Mozdzen* thanked Mr. Olive for starting the meeting until she could arrive.
