#### 7.04 Contract Increase - Universal Athletics

The Board approved annual contracts with estimated spending on June 9, 2021. At that time, \$150,00.00 was estimated for Universal Athletics utilizing State Contract ADSPO18-208273 for athletic equipment and supplies. The District requested approval to increase the total amount to \$225,000.00 for additional items needed for the remainder of the 2021-22 school year.

#### 7.05 Salt River Project Easement

Salt River Project (SRP) is planning a new 69 kilovolt (kV) transmission line which will connect the Humphrey Substation to the Turpen Substation. For SRP to facilitate this new transmission line it is necessary to acquire an easement across the northwest portion of the property at Basha High School. The appraisal value of this 28,619 square feet easement is \$189,709. Recommended approval of 28,619 square feet easement to Salt River Project for the appraised value of \$189,709.

### 7.06 Change Order for Chillers at Hull Elementary School

On January 12, 2022 the Governing Board approved the replacement of chillers 2,3 and 4 at Hull Elementary School. Chiller #1 is being replaced through a Building Renewal Grant funded by the School Facilities Board (SFB). Currently the SFB does not have sufficient funds to replace chiller #1. The SFB has informed us that if the District pays for chiller #1, the SFB will reimburse the District retroactively when funding is available. Request a change order in the amount of \$163,799.25 to UNI-TECH, the Contractor of record on the project.

Concord General Contracting is the general contractor for this project, using a Job Order Contract via 1GPA which complies with all school procurement rules. The District and Concord General Contracting negotiated a Guaranteed Maximum Price (GMP) of \$475,584.00.

### 9.02 Superintendent Comments

Frank Narducci and Leo Schlueter watched some of the Elementary Honors Choir perform at the Chandler Center for the Arts today and there will be more tomorrow. Mr. Narducci thanked Angela Story, Megan Vogus, Katie Landon, and Melissa Trafficante for helping to coordinate efforts to make this event happen.

The high school winter sports season is ending and CUSD schools have performed exceptionally! Casteel High won three team state championships in a span of only 4 days. First, on Saturday night the Colts repeated as Division II boys state wrestling championship with five athletes winning their weight division. Then Tuesday evening, Casteel made it a Two-for-"Twosday" by winning the girls and boys 5A title in soccer. The girls won their third title in five years in the opener, beating Sunrise Mountain of Peoria, 2-0. The boys concluded an undefeated season with an exciting 2-1 overtime win over Sunrise Mountain as well.

ACP Principal Rob Bickes was recognized at the State Student council Convention for his dedicated efforts and leadership during the transition of ACP High School to a new campus and the support of the ACP High School students and council. Holocaust education virtual tours were held this week in 9<sup>th</sup> grade World History classes. Curriculum Director Dr. Jessica Edgar reviewed and recommended those units of study.

There will be two 6A state championship contests on Thursday night. Perry High girls' soccer team faces Xavier Prep. Chandler High boys' soccer has been kind of a Cinderella story. They were seeded at the No. 13 spot and have advanced all the way to Thursday's title game versus Desert Vista. In addition, Perry High girls basketball team will be playing in semi-final action on Thursday night. All of the athletic team champions, including wrestlers who won individual medals Saturday, will be invited to a board meeting in March.

The Chandler Innovation Fair (CIF) was an incredible success. CIF featured student innovation as the cornerstone of the event, including the Hamilton Invitational Science and Engineering Fair research and projects and student inventions. The turnout was incredible, with a combination of great weather and great event. Mr. Narducci thanked the Curriculum & Instruction Department as well as Renee Sweeden, teacher specialists who were involved, all teachers, administrators and students who made this event a success.

Our friends at the Sun Lakes Rotary Club continue to recognize a Teacher of the Month. It's a very nice honor, with recognition at a club breakfast and cash reward. Tracy Phillips, science teacher from SJHS, was honored in February.

Tax season is upon us. The District is pleased to announce the Chandler CARE Center, in collaboration with City of Chandler and Mesa United Way, is a free Volunteer Income Tax Assistance (VITA) site. Chandler residents from low-to moderate-income households can receive free tax preparation on Fridays from 12-4 pm and Saturdays 9:00 am - 12 noon at the CARE Center through April 15th. CUSD students from 13 schools participated in the "Valentines for Veterans" project from Congressman Greg Stanton's office. Cards were picked up and delivered to Veterans across the valley on Valentine's Day. This is something our schools coordinate with Representative Stanton's office and is meaningful for both the students and Veterans.

More student accolades:

- Chandler Early College junior, Kirra Kaufman Johnson, won the regional and national award for the "Next Generation Writing Contest." Congratulations!
- Hamilton High's Academic Decathlon team once again earned the Region IV title. This is the team's seventh straight regional title. Based on scores across the regions, they are currently sitting in first place in the state as they prep for the state competition in March.
- Hamilton High senior and AFJROTC Cadet Landry Howard was recently announced as one of 100 world-wide recipients (from a pool of over 12,000 AFJROTC senior cadets) of a 4-year Air Force ROTC scholarship to the university of her choice. The J-100 AFJROTC Character-in-Leadership Scholarship provides benefits including tuition, on-campus housing, books, and a monthly stipend. This is just one of many awards that students receive when they leave Chandler Schools, but it is a very notable one and we want to make sure that Landry is noted for that excellence of work.
