Minutes of a Regular Board Meeting of the Governing Board

Office of the Board Maricopa County, Arizona April 27, 2022 7:00 p.m.

## 1. Study Sessions - 5:30 pm

#### 1.01 ESSER III Update

Dr. Jennifer Fletcher, Executive Director of Accountability, Assessment and Research, presented an update on ESSER III funds by reviewing the strategies established this year. She explained the input received from the community, parent groups, and staff to determine the strategies for the 2022-23 school year.

Board members asked clarifying questions about the tutoring program - what is the return on investment, who is accessing, how many times, how do we measure its effectiveness, etc. Dr. Fletcher and Dr. Edgar will provide that level of detailed information when available in the reports. It was clarified that the purpose of this tutoring program was to take away the barriers of getting students to tutoring and allow greater access for all students. There was discussion about what would be available in summer school. Mr. Narducci clarified that students will not have to pay if they are bridging or advancing. It was suggested from board member that too much emphasis is being put on academic achievement and more emphasis should be placed on the social emotional side.

#### 1.02 Marketing Update

Terry Locke, Director of Community Relations, and Samantha Incorvia, Digital Marketing Coordinator, presented an update on the marketing plan. Terry gave a recap from Spring 2021. Social media focus was on the whole child. Samantha shared the responses/reactions from each platform. The community is heavily a Facebook audience. Terry shared the marketing plans for the 4th quarter and recommendations for moving forward.

Board members asked what the focus would be if the budget was larger and how to clarify which schools are Chandler Unified District versus charter schools. They also wondered if there was a way to determine how families find CUSD and data regarding whether or not parents like the phrasing "Premier district of choice". Terry will look into these options.

### 7.04 Contract Increase - Trane US

The Board approved annual contracts with estimated spending on June 9, 2021. At that time, \$150,000 was estimated for Trane US Inc utilizing Omnia Partners Contract for HVAC Products, Installation, Services and Related Products. The District requested an increase of \$150,000 for a total estimated expenditures of \$300,000 to Trane US Inc for any additional units that may need replacing and/or repair during the remainder of the 2021-22 school year.

7.05 K through 6 Grade English Language Arts (ELA) Resource Adoption – Spanish Translation
There is a demand for vertically articulated, comprehensive K-6 ELA resources to meet the requirements of the Arizona English Language Arts standards. On November 10, 2021, the Governing Board approved the Curriculum and Instruction team's recommendation of Houghton Mifflin Harcourt's Into Reading for grades K-5. At the time of approval ¡ARRIBA LA LECTURA!, the title of the Spanish translation of the Into Reading resources, was not listed on the agenda. There is no additional cost as the Board already approved the six (6) year cost of \$2,245,272.76, which included the ¡ARRIBA LA LECTURA! Spanish resources.

In accordance with A.R.S. 15-721 and CUSD Policy IJJ, the materials were on display in the main lobby of CUSD's Instructional Resource Center (IRC) for sixty (60) days beginning September 9, 2021 for public viewing and input. Digital access to the materials on sixty-day review was available for public viewing via the following website: https://www.cusd80.com/Page/113622. Recommended approval of the above referenced Spanish translation of ELA resources for grades K-6.

8.01 <u>Hamilton High School Performing Arts Center Audio System Upgrade</u>

Hamilton High School opened in 1998. The audio equipment in the Performing Arts Center is the original and in need of replacement. CCS Presentation Systems evaluated and provided a recommendation to upgrade to put Hamilton High School on par with the other High Schools. The cost of this upgrade is \$199,739.89. The District will procure this upgrade with CCS Presentation Systems via an Arizona State Contract which compiles with all school procurement rules.

Approve CCS Presentation Systems in the amount of \$198,987.44 for the Hamilton High School Performing Arts Center audio system upgrade.

### 8.02 Frye Elementary Sewer Rehabilitation

Frye Elementary School was built in 1978. The sewer lines need restoration as they are showing signs of cracking and are beginning to accumulate debris. The school also has 48 sewer vent pipes that need replacement due to cracking and/or complete blockage. The District will contract with Concord General Contracting via a 1GPA Job Order Contract which complies with all school procurement rules in the amount of \$962,402.

# 8.02 <u>Frye Elementary Sewer Rehabilitation</u> (cont'd)

The scope of work for the project includes the following:

- Trenchless pull in place structural lining for main, lateral and branch lines (1,706 feet).
- Remove 48 iron vent pipes and replace with ABS (acrylonitrile butadiene styrene) pipe.
- Tile and drywall patch back and repair.

Approve Concord General Contracting in the amount of \$962,402 for the Frye Elementary sewer rehabilitation.

### 8.03 <u>Frye Elementary Classroom Casework</u>

Frye Elementary School was built in 1978. The classroom casework is original and in need of replacement due to the invasive nature of the sewer re-piping. The District will contract with Concord General Contracting via a 1GPA Job Order Contract which complies with all school procurement rules in the amount of \$808,907.

The scope of work for the project includes the following:

- Remove, replace existing casework and solid surface countertops.
- Remove and replace classroom VCT (vinyl composite tile).
- Remove sinks and associated plumbing and install existing sinks back into new casework.

Approve Concord General Contracting in the amount of \$808,907 for the Frye Elementary classroom casework.

### 8.04 San Marcos Fire Alarm System

The fire alarm at San Marcos Elementary was last updated in 1993 and needs replacement. The current FACP (fire alarm control panel) is not programmable, and the most recent fire inspection deemed the alarm non-compliant. The District will contract with Copper State Fire Protection via the Mohave contract which complies with all school procurement rules in the amount of \$189,724.00.

The scope of work for the project includes the following:

- Remove current FACP, devices and wiring that is not compatible.
- Install new NOTIFIER Addressable Fire Alarm NFS2-3030.
- Install new LCD 160 Annunciator.
- Install all required modules to monitor sprinkler riser flow and tamper switches.

Approve Copper State Fire Protection in the amount of \$189,724 for the San Marcos Elementary fire alarm system.

#### 8.05 NP5000 Building and Grounds Improvement Projects

As part of the 2021-2022 NP5000 process seven building and grounds improvement projects were identified by District Administration and are being recommended for approval. The District will contract with Concord General Contracting via a 1GPA Job Order Contract which complies with all school procurement rules in the amount of \$795,517.

8.05 NP5000 Building and Grounds Improvement Projects (cont'd)

The projects are as follows:

CTA - Goodman Elementary - \$66,440

• Placing a 30'x 22' fabric shade structure over a concrete slab in the parent pick up area.

#### Andersen Elementary - \$147,789

- Placing (2) 37'x 26' fabric shade structures over playground equipment.
- Putting a concrete slab in high traffic area on the west side of the school.

#### ACP Middle School - \$257.821

- 2600 square feet of concrete for the outdoor dining area.
- Block fence around SRP gear and outdoor ceramics kiln.
- Reroute drainage issue.

### Bogle Junior High - \$87,993

- 84 feet of steel fencing and (3) man gates with panic hardware.
- The fence will help funnel visitors to the front office.
- It will help keep all students within the gated area.

#### Galveston Elementary - \$27,204

Replace rolling kitchen steel gate with double swing gate.

### Basha High School - \$143,195

- 2200 square feet of concrete for baseball bleachers.
- 1200 square feet of concrete for softball bleachers.

#### Perry Auxiliary Building (Network Technology Site) - \$65,075

• Add 2 toilets, relocate 1 urinal, remove 2 sinks, and replace with 1 sink.

Approve Concord General Contracting in the amount of \$795,517 for the NP5000 building and grounds improvement projects as outlined for CTA Goodman, Andersen Elementary, ACP Middle School, Bogle Junior High School, Galveston Elementary, Basha High School and Perry Auxiliary Building.

#### 8.06 Casteel High School Tennis Courts and Concessions Facility

Casteel High School was built in 2015 with (4) tennis courts. Chandler Unified School District comprehensive high schools have (8) tennis courts which is necessary to complete high school AIA (Arizona Interscholastic Association) matches during daylight hours after school. To bring Casteel High School on par with the other high schools, it is proposed to construct (8) tennis courts and a 2,718 square foot concessions and restroom building that would service both the tennis courts and the Chandler Unified School District Beach Volleyball Courts. The 4 existing courts will be turned into outdoor basketball courts for the physical education department.

A RFQ (request for qualifications) was issued, and Chasse Building Team was selected as the general contractor of record. The District negotiated a GMP (guaranteed maximum price) in the amount of \$4,396,202 which the District believes is fair and reasonable given the current market conditions.

Approve Chasse Building Team in the amount of \$4,396,202.00 for the construction of the Casteel High School tennis courts and concessions facility.

CTA Liberty has added a preschool program and is experiencing growth in enrollment requiring relocation of 2 modular buildings from Haley Elementary. McCarthy Building Companies has been selected via a 1GPA (Job Order Contract) which complies with all school procurement rules in the amount of \$570,485.00.

8.08 <u>Emergency Responder Radio Communications System Install (ERRCS) at Basha High, Chandler High and Hamilton High School</u>

The City of Chandler has adopted the 2018 International Fire Code (IFC), section 510, as the applicable code for in-building enhancement testing, system installation, and system verification. After further testing by US Mobile Communications, a City of Chandler approved vendor for radio communications systems, it was found that Basha, Chandler, and Hamilton High Schools do not provide adequate radio coverage for emergency responders and are not in compliance with Section 510 of IFC 2018. The district will contract with Concord General Contracting via 1GPA job order contract which complies with all school procurement rules in the amount of \$276,534.

The scope of the project includes:

- Installation of ERRCS 700/880MHz at Basha High School
- Installation of ERRCS 700MHz at Chandler High School
- Installation of ERRCS 700MHz at Hamilton High School

Approve Concord General Contracting in the amount of \$276,534.00 for the ERRCS (Emergency Responder Radio Communication System) installation at Basha, Chandler, and Hamilton High Schools.

9.02 <u>Aircraft Owners and Pilots Association (AOPA) High School Aviation STEM curriculum adoption - CTE Air Transportation program - C-TEC Drone Operator courses</u>

The Aircraft Owners and Pilots Association (AOPA) High School Aviation STEM curriculum offers comprehensive curriculum aligned to Common Core State Standards, Next Generation Science Standards, and CTE Standards. The AOPA curriculum will be used specifically for the Career and Technical Education Air Transportation program, which will be part of the C-TEC Drone Operator courses, grades 9-12. Each course is a turn-key set of high qualify instructional and assessment resources written by veteran teachers, curriculum professions, pilots, and flight instructors. Teachers will access the curriculum electronically through the AOPA websites. Every lesson includes everything a teacher needs for a rigorous and project-based learning experiences.

In accordance with ARS 15-721, the curriculum will be placed on display for the 60-day public review period for comment at the Melinda Romero Instructional Resource Center starting April 28, 2022. After the 60-day review period for public comment, the curriculum will be presented for approval.
