Minutes of a Regular Board Meeting of the Governing Board

Office of the Board Maricopa County, Arizona April 12, 2023 7:00 p.m.

1. Study Session - 5:00 pm

1.01 <u>Technology Update</u>

Colleen Flannery, Chief Technology Officer, presented a technology update explaining how technology supporting education has moved to technology leading the learning. Colleen introduced the tech team, and shared the objectives and goals post COVID and the major initiatives and priorities. She discussed what teachers need to move forward, the learning environment, cyber security, student safety, how to attract and retain talent, and the budget. Interactive Flat Panels were demonstrated to show the flexibility in digital curriculum.

- A huge donation just came into the Chandler Education Foundation. Subaru of Chandler donated \$80,000 from their Share the Love promo campaign that they run each year. This is the largest check to date for the Foundation! The money will all go towards their support of Lifelong Learning by assisting teachers who may want to pursue a specialized certification...i.e., national board certification or other certifications to attract and retain qualified teachers.
- Another celebration for the foundation. A local businessman Robert Valentin won the Chandler Education Foundation Winner's Choice Cash or Car raffle. Robert owns a local barbershop on Arizona Avenue and purchased two tickets from one of his clients, a foundation board member. Robert chose the cash option and said he looks forward to purchasing again next year.
- CUSD's annual elementary track and field meet was held April 3 at Perry High School. It was an awesome event as always seeing the stands packed, the pageantry of elementary school colors, and spirit of camaraderie that filled the stadium. It was a great night and Mr. Narducci thanked all our physical education teachers for their hard work to prepare students for the night, specifically PHS staff and students for hosting the event, Bill Tuttle and District Athletic Director Shawn Rustad for their organization of the event. Mr. Narducci pointed out that Riggs Elementary won the girls' competition and Santan Elementary won the boys' meet.
- Chandler Unified School District's student-artists will put their work on display for the community

 19 through May 11. Artists from all CUSD high schools display their talents through ceramics,

6.01 <u>Citizen Comments</u>

Darin Hookom - CUSD Admin - Have been demanding justice and accountability for a situation over 2 years ago that he does not feel was documented and reported properly, and continued until more voices came forward. He requested the board honor those young voices and work with law enforcement for a proper investigation.

Katey McPherson - Sexual Harassment - Met with four members of leadership team, Mr. Narducci, and have been ignored. This is a complete failure of the principal and HR Department when children report to trusted adults and their complaints are not given serious consideration,

Cassie Skufca - Recent District PD - Expressed disappointment at professional development when learning Dr. Howard canceled at the recent Professional Development. Students are not all the same, so it is vital for professional development related to social-emotional learning and teaching.

Tiffany Benson - General Public Comment - Turning Point USA's message is not one of hate, but of truth and love. Look forward to seeing Freedom clubs in all CUSD high schools.

6.01 Citizen Comments (cont'd)

Kathleen Winn/Project 25 - Administration Failure to Report - Was contacted by families of students who believe administration did not take proper action. Administrators have a huge responsibility to deliver a safe environment. October 3, 2022 a teacher was given option to surrender or do a public hearing with the State Board of Education. The fact that the teacher chose to surrender should speak louder than anything. Federal investigators are involved. Hope CUSD does better in the future.

Roswell Olson - Extent of Medical Science re: John Hopkins University - Requested the board instruct and give direction to make constitution a special day of teaching and instruction.

Benjamin Larrabee - Health of CUSD Students - Addressed slanderous claims against Turning Point USA. The real threats and challenges are that we have the lowest ACT scores in over three decades. Childhood obesity has doubled; poor mental health; students considering suicide have increased significantly since the pandemic, and half of our students come from broken homes with no father in them. Our job is to acknowledge that we are seeing a real decline in students in one of the richest countries in the world.

Abbigail Traylor - Glass door at Navarrete Elementary - Safety issue. Large doors with metal and glass are a safety issue. Staff has complained, but nothing has been done. The purpose of this statement is to establish this notification as a public record.

Hayden Nguyen - LGBTQ Mental Health - Requested bathrooms for nonbinary students close to their classrooms and affirm transgender students by making it easier to change names. CUSD is undergoing horrid negligence for LGBTQ students.

Dawn Shim - LGBTQ Mental Health - There are so many stories how this board is negligent, yet this board has not taken any action. High School students will walk out this Friday. I have a few demands for you to enforce: 1) trans students need inclusive bathrooms; 2) mental health considerations for LGBTQ students; 3) cultural equitable competency; 4) transgender student affirmation by using proper name; Crystal Markowski - Mental Health - Protecting students is first priority. You must listen to students here and acknowledging their needs, can create an environment for them to thrive.

Jennifer Alvey - List of 7 - There are recent incidents of staff promoting gender, queer, and violations of parents' rights laws. Teachers are contacting parents sharing where they see problems happening including CUSD scheduling a known advocate of CRT as a presenter for recent teacher inservice; High School counselor asking teachers to pass out pamphlets about an off-campus gender queer club; Junior High Counselor who ran a secret gay/straight alliance club without school or parent awareness; CUSD teacher selecting a student project to display high school students in the hall which promotes gender-queer theory; High school counselor willing to violate laws by keeping information from parents, if the students request; High School using gender-queer titles for their prom royalty; Abuse and coverup at CCHS. These are our children. Parents are happy to partner with teachers, administrators, and staff to address the situations that need improvement.

Shannon Hayes - Policy - Concerned for a black mother who has been trespassed at BJHS. There are no true policies in place regarding trespass and it goes against parent rights. Requested a meeting with the board, parents, and superintendent.

8.04 Possible Litigation Against Social Media Companies

Requested approval regarding the District becoming a Plaintiff in Litigation against companies operating social media platforms, including: (a) a decision whether to participate in the litigation as a Plaintiff; (b) a decision whether to approve legal counsel to represent the District in the litigation; and/or (c) a decision whether to approve an engagement agreement of legal counsel to represent the District in the litigation. JoJo Tann, attorney, explained his practice is dedicated almost exclusively to represent public entities and civil litigation primarily against Fortune 500 companies. He currently serves as lead counsel for the city of Tucson in the national opioid litigation, as well as several Arizona School Districts including CUSD in the JUUL Vaporizing litigation. The next battle is social media. Research suggests that algorithms, corporate decisions, and business strategies of social media companies have contributed to unprecedented rates of anxiety, depression, thoughts of self-harm, body image issues, and suicidal ideations in school children. These social media companies design their platforms to negatively impact youth mental health in order to boost their profits by maximizing the amount of time kids spend on their platforms, just so they can sell more ads. China limits the amount of time children can spend on their platforms to less than 40 minutes per day. They measure everything you do on their product specifically in order to make them more profitable. This is not about shutting down social media, but to have them stay in their lanes and providing funding to our schools to abate the nuisance and educate children about the negative impacts of nonstop use of social media. In the United States, according to the Surgeon General, 1 in 5 children now have a diagnosable mental health disorder. We need the resources to address this critical mental health issue. Education funding in Arizona is towards the bottom in the country, we think the corporations who have made billions and billions of dollars should be held responsible for funding this effort.

9. Information Items

9.01 Student Activity, Auxiliary Operations, and Tax Credit Reports

Student Activity (SA), Auxiliary Operations (AUX), and Tax Credit (TC) Reports for the months ending July 2022 through March 2023 were provided.

9.02 Food and Nutrition Vehicle Purchase

The Food and Nutrition Department is in need of a catering transit van and delivery box truck that are temperature controlled for daily operations. Multiple attempts were made to reach out to contracted vendors the District has worked with for vehicle purchases, but vendors were either unable to supply the vehicles within the timeframe needed or did not supply temperature controlled vehicles. However, Aramark was able to secure the vehicles through one of their vendors. Attorneys from both parties reviewed the contract (RFP 07-23-27) between the District and Aramark and came to a mutual agreement that the vehicles could be purchased by Aramark and reimbursed by CUSD. CUSD will reimburse Aramark for the vehicles purchased and will own the titles to both vehicles.

9.03 Secondary Curriculum - Introduction to Sociology

Introduction to Sociology will be a new elective offered to students in the 2023-2024 academic year. The Introduction to Sociology text has been vetted by teachers, department chairs, and academic coaches. The committee is recommending the following textbook to move forward in the textbook adoption process:

Cengage's Sociology: The Essentials, 10th edition, written by Margaret Andersen and Howard Taylor, published in 2020.

The cost for a class set (40) is \$5,742.00 including estimated tax, shipping, and processing. The purchase for this resource will be paid for using site funds.

In accordance with A.R.S. 15-721, the textbook will be placed on display for the 60-day review period for comment at the Melinda Romero Instructional Resource Center starting April 11, 2023. After the 60-day review period for public comments, the textbook will be presented for approval.

9.04 Revision to Policy GCI - Professional Staff Development

Board Member Kurt Rohrs requested changes to Policy GCI - Professional Staff Development to include language requiring all workshops and programs designed for staff development and in-service trainings to be approved by the Governing Board prior to presentation.

Mr. Rohrs stated recent training that generated dismay from community members and teachers due to the controversial nature of the presenters. Controversy surrounding the event indicates questionable decision-making by event organizers. Senior staff did try to vet the content, but further oversight by the public body should be implemented. Both Curriculum and Policy are under the jurisdiction of the Governing Board; however, it is not currently indicated in the Staff Development policy. A revision adding language will provide greater transparency to allow the Governing Board to fulfil its responsibilities of the public body.

9. Information Items (cont'd)

9.04 Revision to Policy GCI - Professional Staff Development (cont'd)

Board members discussed the volume of training and professional development opportunities and the fact that staff, the experts, are in place to oversee and vet each training. The Governing Board members are not sufficiently trained to do so and would bog down the system and require more meetings to vet each area. Mr. Narducci explained the offerings were quite extensive, inside and outside of the District, and workshops to meet statute are incorporated in everything CUSD does. He explained the Board hires the experts to do this work and there has to be a level of trust in the individuals hired to do the job. Mr. Wirth stated approving all professional development would be cumbersome and bury the board in paperwork and offered the option of the board receiving information for the exceptions. Mr. Rohrs acknowledged that the Board would not have to approve all professional development, stating there were comments from the community that they did not like it and they deserve a voice. Board members stated that educating each member would become problematic and micromanaging and currently the system is not broken, so there is no need to fix it. Mr. Rohrs said the public body has the right to responsibility and the responsibility is the Governing Board's, not the administration. Mr. Narducci stated that the District would continue to follow the statutes surrounding professional development for teachers and is concerned whether this could be accomplished in a timely manner. Dr. Nance stated that some trainings are implemented with regards to a need and if it had to be approved by the Governing Board, would result in a disservice to students and teachers. Mrs. Serrano cautioned that the Board should be careful to keep this about policy and not just one event. She reiterated there is not one board member currently that is an expert in curriculum instruction and pedagogy, reiterating that they cannot be experts on all topics. This would be impacting policy and more than just one inservice day. She advised that the District's Mission, Vision and Core Values be considered along with Portrait of a Learner. Mr. Rohrs stated that comments from the community are what brought this to the floor, and he offered to work through some of the issues discussed and polish the language and present something a little more clear.

9.05 Revisions to Policy GCCF and Regulation GCGC-R

Contracts are issued in March, so CUSD Administration is recommending changes to notification deadline dates in Policy GCCF - Sabbatical Leave and Regulation GCGC-R Job Sharing in Professional Staff Positions. These modifications are presented for information. Approval for Policy GCCF will be requested at the April 26, 2023 board meeting; Regulations do not require approval.

9.06 CUSD Board Agenda Roadmap

Board members discussed upcoming events and activities.

9.07 Board Member Current Events

Kurt Rohrs attended the Tarwater garden project event. Tarwater received help from community members, and it is something that students can apply what they have learned. He thanked the principal and staff at Tarwater.

Joel Wirth complimented the District reiterating that health insurance is very important to staff. The rates from the Trust are fantastic and complimented the Trust for what they are doing.

Patti Serrano reported on the Valley Interfaith project before spring break, stating it was a great, informative event on how we can support mental health issues and get involved with life-saving efforts. Several staff and board members were present. She encouraged involvement.

CUSD students will be showcasing livestock at the Fair and selling their livestock with proceeds to invest in their college, another animal project, leadership opportunities, and more. Santan 4H Club, CHS FFA, and KH Showcase member, Annabelle Williams, who provided this information and a personal invitation to attend.

Cinco de Mayo students and staff at CHS are planning an educational and entertainment event at Chandler Center for the Arts, Friday, May 5th, 5:00 pm.

Patti echoed valid concerns expressed tonight about district staff missing the opportunity for professional development on the subject of creating culturally responsive and caring schools for all children. These types of professional education directly align with the District Mission, Core Values, and Portrait of a Learner. She encouraged administration and hopes the opportunity is available in the future for staff for the wellbeing of all of our schools.
