3.02 Superintendent Current Events

Governing Board members yesterday was Bus Driver Appreciation Day. We are so thankful for our drivers and bus attendants. Chandler Unified students showcased their exceptional talents at the Arizona State Science and Engineering Fair. Despite representing only 3% of Arizona's student population, CUSD students triumphed by claiming more than one-third (34%) of the state's award-winning projects. In addition, CUSD comprised 31.5% of the International Science and Engineering Fair (ISEF) Qualifiers from Arizona. The AzSEF awards event showcased an impressive display of accomplishments, including 19 first place winners, 19 second place winners, and 22 third place winners.

Chandler Unified School District (CUSD) is proud to celebrate 150 seniors in the Class of 2024 (31 more than 2023) who earned fine arts seals on their diplomas. 6.02 Contract Increase- Community Education Enrichment Programs

The Governing Board approved RFP 05-24-28 for the Community Education Enrichment Programs with estimated expenditures of \$1,100,000.00 on November 15, 2023. The District requested approval of an additional \$295,000.00 for a new total amount to \$1,395,000.00 for the remainder of the 2023-2024 fiscal year. Through District wide efforts to expend out ESSER funds, Community Education has experienced an increase in CUSD enrollment. In addition, Community Education, collectively, has also presented multiple offerings (programs and classes) that have driven these higher enrollments. As an example, Kids Express Summer Camps are currently at maximum capacity and will be offering STEAM enrichment for those students enrolled.

Board Comments:

Mr. Rohrs requested that this agenda item was moved from Consent to Action to inform the public. He asked if this request was a re-allocation. Dr. Nance informed the Board that the request will be funded by the remainder of ESSER funds that will expire at the end of the year.
