7.03 Intergovernmental Agreement with Arizona Career and Technical Education (CTE) Curriculum Consortium for the 2024-2025 School Year

The Board approved the initial IGA for AZ CTE Curriculum Consortium in June 2013. The IGA was renewed and signed by both CUSD and PIMA JTED in November 2016 and again in August 2020. The new IGA for 2024 is attached for submission to the Board for approval.

Through our participation, CUSD will receive quality professional development for our CTE teaching staff to enhance teaching and learning as well as access to the online electronic library of Consortium CTE Instructional Materials, referred to as the CTE Curriculum Connection. The CTE Curriculum Connection contains for 1,000 common designed lessons to over 21 CTE programs.

The cost to CUSD associated with program membership, maintenance, ongoing development, and necessary revisions is projected not to exceed \$19,655.40. Career and Technical Education funding will be utilized to fund CUSD's participation. The new IGA for AZ CTE Curriculum Consortium 2024 for submission was provided to the Board for approval.
