# AP 2024-2025

Hello AP families! Welcome to the 2024-2025 school year!

Taking the Advanced Placement exam is an important part of all AP courses. Scoring well on a student's AP exam can often earn them college credit for their high school class, saving a significant amount on tuition. Below is some detailed information on College Board and AP exam registration and payment. We have this information and more on our website:

### Now through October 25

- Students will need to register for AP exams in 2 systems! This should take no more than 10 minutes total.
  - o First, please register in Total Registration at <a href="www.TotalRegistration.net/AP/030037">www.TotalRegistration.net/AP/030037</a>. This system helps AP coordinators track payments, verify the correct number of tests are being ordered, and communicate with you regarding testing.
  - o Second, please register in College Board. <a href="https://apstudents.collegeboard.org">https://apstudents.collegeboard.org</a> . You will need the join code provided by your AP teacher (the last page in total registration also has join codes listed).
- **ALL AP students must register in College Board and Total Registration, even if they will not be taking the exam.**
- ❖ If you will be taking the AP exam and have completed your registration in College Board and Total Registration, you will need to pay for your AP exams. AP Research and AP Seminar exams will cost \$150 each. All other AP exams will cost \$100 each. Payment can be made in BHS bookstore (cash, card, or check made out to Basha High School) or online through the parent portal (More, In Touch Fee Payments, Select your student, Items at Student's School under "Shop", TESTING under "Categories", AP exam. Add quantity and check out.)

If you will be taking the exam, you must be registered in both College Board and Total Registration AND have payment made by October 25, 2024 to avoid late fees.

#### After October 25

- ❖ You will need to see Mrs. Lindvig or Mr. Unger in the front office if you still wish to take the exam. You will not be able to access Total Registration and will be charged a \$40 per exam late fee (as set by College Board).
- There will be a window in January ONLY for students taking 2<sup>nd</sup> semester Government and Econ classes to register without a late penalty. The deadline to register and pay for those 2<sup>nd</sup> semester classes is 2/14/25.

#### REFUNDS

❖ If you wish to cancel your AP exam registration, please see Mr. Unger or Mrs. Lindvig in the front office. A full refund will be available until 10/25/24 and a 50% refund will be available 10/26/24 through 2/14/25. Refunds will only be an option for those who have paid into the auxiliary account.

#### Other Information

- ❖ Students on Free/Reduced lunch Please see Mr. Unger or Mrs. Lindvig in the office for payment options.
- ❖ Students with 504/IEP Please work with your counselor to apply for accommodations for AP testing. Your accommodations must be approved by College Board 1st semester to be valid for AP testing 2025.
- ❖ If you are a Basha student taking an AP class through COA and want to take the exam, please contact COA for join codes and information on AP Exam testing with COA.
- ❖ If you are scheduled to take 2 exams at the same date and time (example: Chem and Human Geo) please reach out to Mr. Unger or Mrs. Lindvig for options.
- ❖ If you are interested in self-studying for an exam that is not currently offered at Basha High, please see Mr. Unger or Mrs. Lindvig. We are generally able to accommodate your requests.

Now through October 25	Once registered in both College Board and Total Registration, please pay for your AP exams through the parent portal or at the BHS Bookstore.  AP Research and Seminar exams are \$150. All other AP Exams cost \$100 each.	AP exams are tax credit eligible. Payment through the parent portal will default into the AUX account. You may choose to have your payment moved into the tax credit account in order to claim the expense on your taxes. To do so, please make the request via email to our bookstore at <a href="mailto:Gooslin.Elveda@CUSD80.com">Gooslin.Elveda@CUSD80.com</a> Refunds will not be an option for any reason for payments moved into the tax credit account. Refunds will only be an option for a limited time to those who have paid into the aux account.
October 26-November 8	You will need to see Mr. Chandler or his assistant in the office if you wish to register and pay for AP exams.	A \$40 <b>per exam</b> late fee will be applied.
January 21- Feb 14, 2025	Window open for 2 <sup>nd</sup> semester Government and Econ classes <b>only</b>	Register through College Board, Total Registration and pay through the parent portal or at the BHS bookstore
May 5 – May 16, 2025	Take your AP exams! See the AP Exam Calendar 2025 for the dates and times of your tests!	More information will come from your AP teachers and reminders will be sent through Total Registration as testing dates approach.
